After the half term break we will be sending out a questionnaire about our wraparound care provision and I would ask that you please complete and return it as it will help to inform how we develop our provision going forward.

Our grant from the Weardale Area Action Partnership expires at the end of February. I am relieved to announce that we will continue to provide both Breakfast Club and After School Childcare, however, this may have to be in a different format and changes will be necessary if we are to continue with the provision. At the current time, without the grant funding we would be making a $\pounds1,500$ loss so far this academic year and this is obviously not sustainable for the school.

I do however, understand how important this provision is for our working families; emergency situations; respite care and support and have therefore taken the decision to continue with the provision with some changes.
